COMMITTEE BEAT

Economic Affairs and Taxation Committee

JCC Tax Reform Meetings

Prior to the tabling of the Budget, the Committee (Keith Collister, Roy Collister, Ethlyn Norton Coke and Elizabeth Hartley) spearheaded the Chamber's lobbying efforts with the Government, moving from an initial draft position paper recommending, among other things, a reduction of GCT to 10%, and the rationalization of import duties.

The Budget

The Committee assisted the Government technocrats with the difficulties arising from the confusion with the GCT List.

IADB Facility

As at the end of March, only U.S. \$60 million of the U.S. \$300 million IADB loan to the local private sector (through DBJ) has been disbursed.

Export Led Growth Strategy urgently required

Against the background of the virtual collapse of the bauxite sector and the fall in foreign exchange flows from tourism and remittances, Jamaica needs to urgently adopt an aggressive export led "Gateway " growth strategy, driven largely by a low corporate tax rate accessible by both foreign and Jamaican investors.

Dialogue with the Police

Dialogue continued on Tuesday, March 3, 2009 at the Commissioner's on the issues of School Safety and Community Based Policing. National Export Strategy

On March 4, 2009 a meeting was held at JTI to review the progress to date of the Plan. A “validation” meeting was held on 17th March 2009 and the NES was subsequently presented by Minister Samuda during the Budget Debate.

Meeting of the “Core Group” on Canada 12th March 2009.

The meeting at the MFA&FT concluded that an FTA with Canada was not attractive for Jamaica at this time for numerous reasons. Moreover as the FTA was a COTED directive, the dilemma was how to influence the political directive based on economic realities. It was proposed that COTED be requested to seek a five year deferment of the negotiation, as with the world economic crisis Jamaica would not be ready for the round particularly on the supply side, in addition to waiting for the crucial conclusion of the WTO Doha Development round.

The Caribbean Council Meeting Tuesday 7th April 2009.

Ms. Stephanie Whittle, Associate Director to the Caribbean Council advised about an all day Caricom Conference on “Implementing the Economic Partnership Agreement” which is scheduled to be held on 21st May 2009 at the Hilton Hotel. The Conference increased the understanding of how and when the EPA’s provisions will be implemented, and the ways in which the private sector may take advantage of the Treaty’s provisions to increase competitiveness during an economic recession.

LEGS AND REGS COMMITTEE

In this Phase III of the reengineering of the Development Approvals Process Project (under the extended Cooperative agreement signed with USAID, now scheduled for completion by 30th September 2009) funding has been received to cover the setting up of a Development Assistance Centre and roll out of the AMANDA system to the Parish councils which will facilitate the tracking of applications.

The Project is a collaborative effort with the Government (through OPM and Minister Montegue and Minister Vaz).
